## INTRODUCTION: PRE- WORLD WAR I RECORDS OF THE IMPERIAL GERMAN NAVY AND ITS PREDECESSORS, 1822 – 1919

This guide identifies and partially describes the records of the Imperial German Navy and its predecessors for the period prior to the outbreak of World War I, extending as far back as 1822. The records are reproduced on 305 of the current total of 4,317 rolls of National Archives Microfilm Publication T1022, Records of the German Navy, 1850-1945, Received from the United States Naval History Division. The records are arranged in three groups: (1) organizational records and central files, 1822 -1919; (2) records relating to overseas stations, colonies, and gunboat diplomacy, 1854 - 1914; and (3) records relating to German naval attachés, 1901 - 1930. Within each group, the records are arranged by organizational hierarchy and the original German filing designations. Each record item bears a "PG" (purportedly an abbreviation for "pinched from the Germans") numerical designation allocated by British authorities after the records' seizure at the end of World War II to facilitate subsequent intelligence exploitation. These "PG" numbers have been retained as the standard identification of individual record items, although they have no significance in the original German organization or arrangement of records. The filming sequence is similarly unrelated to German provenance or arrangement, thus the records maintained by a specific German Navy office on a specific subject are often scattered among various T1022 rolls.

The originals of the records described are now in the custody of the Bundesarchiv-Abt. Militärarchiv (BA-MA) in Freiburg/Br., Germany, where they constitute portions of at least four record groups (Bestände). Although the focus of this guide concerns the prewar period, perhaps 10% - 15% of these records constitute subject files begun prior to the war but continued during the 1914-18 period (particularly the correspondence of naval attachés). As the records constitute continuations of specific files or collections, they have been described in this finding aid to retain the coherence and unity of documentation.

The volume and complexity preclude detailed descriptions, instead each German record item typically includes the full German-language file or series designation and title, a parenthetical English-language summary of contents, date span, and citation to "PG" item number and T1022 roll number. For the group of records pertaining to overseas stations, colonies, and gunboat diplomacy, some additional description has been included in the parenthetical summaries to identify specific German Navy warships involved in the operations described. In addition, introductory notes at the beginning of each of group description provide references to the corresponding *Bestand* designations in the *BA-MA*. A familiarity with the German language, and with the German handwritten style in use

prior to 1900 (Süterlin), is required to effectively use the filmed records and accompanying descriptions.

The records document the organization, funding, and overseas activities of the Imperial German Navy (Kaiserliche Marine), 1871-1918, and its predecessors, the Prussian Navy (1822-67) and the North German Federal Navy (Bundesmarine) (1867-71). Prior to November 1853, naval affairs fell under the authority of the Prussian Ministry of War (Kriegsministerium), as part of the Allgemeines Kriegsdepartement - Abt(h)eilung 4 (Marineangelegenheiten). From November 1853 to April 1861 naval authority was centralized in the Königlich Preussische Admiralität (Royal Prussian Admiralty). From April 1861 until July 1870, however, this authority was divided between an operational headquarters, Ober-Commando (later Ober-Kommando) der Marine (Naval High Command) and an administrative headquarters, the Marineministerium (Navy Ministry). After late July 1870 the Ober-Kommando der Marine became nominally subordinate to the Navy Ministry, which was redesignated the Kaiserliche Admiralität (Imperial Admiralty) on 1 January 1872. In fact, however, little was accomplished in unifying naval organization, and following the accession of Wilhelm II as Kaiser the Imperial Admiralty was abolished in April 1889 and the division of authority restored with the establishment of the Kaiserliche Oberkommando der Marine responsible for operational matters and the Reichs-Marine-Amt (Reich Navy Office) responsible for organization and administration. Disputes between the two authorities resulted in March 1899 with the dissolution of the Kaiserliche Oberkommando der Marine and the assumption of direct command by the Kaiser himself, who retained one component - the Admiralstab der Marine (Admiralty Staff/General Staff of the Navy) - as an executive operational staff. In April 1899 the Kaiser also established the Kaiserliches Marinekabinett (Naval Cabinet) to facilitate his personal command of the Navy and naval affairs, though in practice this body concentrated on naval officers' personnel matters.

The records described here reflect this overlapping and sometimes duplicative situation in their content and arrangement. Originated or collected by the various authorities noted above, the records were subsequently reorganized and maintained as the Archiv der Marine (Navy Archives). Shortly before or during World War I these records, collectively designated as "Friedensakten" ("Peacetime Records"), were organized into a multiple-numeric filing scheme (e.g., Acta IX.1.1.1, Acta XXIVa) that broadly corresponded to general or specific subjects, and thereunder arranged chronologically in numbered Bände or Hefte (volumes). Many volumes include a table of contents that list the principal documents contained. Separately-numbered files, however, often concern the same topic, reflecting the navy's administrative divisions, differing levels of security classification (e.g., separate files marked "Ganz Geheim," the highest security classification for the navy), and other factors. Examples are provided below.

The first group of records described pertain to organizational and central files maintained by a variety of authorities, arranged in four subgroups: (1) organizational records largely maintained by the Kriegsministerium, the Kaiserliche Admiralität, and the Marineministerium that document key aspects of the navy's organizational history, 1822-1889; (2) records of the Kaiserliches Marinekabinett for the period 1889-1918, that

concern naval organizational, training, and personnel matters, and particularly useful for documenting Kaiser Wilhelm II's direct involvement in naval affairs; (3) records of the Admiralstab der Marine, 1892-1918, which primarily document reports and presentations made directly to the Kaiser on various topics, as well collected reports on the Spanish-American War; and (4) records of the Reichs-Marine-Amt (Zentralabteilung), essentially for the period 1896-1916, pertaining to the buildup of the German battle fleet under Admiral Alfred von Tirpitz, the development of the Anglo-German naval rivalry, and the diplomatic crises in the decade before World War I. The contents of these subgroups often complement each other, e.g. the background to the passage of the German Navy laws of 1898 and 1900 and supplemental 'Novellen' of 1906, 1908, and 1912 that governed the establishment of a modern German battle fleet are documented in both the records of the Marinekabinett (esp. Akte If 1, Akte XXXIc) and the Reichs-Marine-Amt (Acta III.1.5.3 through III.1.5.30). The contents of the last two subgroups also include a number of records that directly relate to World War I. Some prewar records of the Marinekabinett that concerned the development of naval airships (zeppelins) are not described here, but will be included in a future guide to World War I naval records.

The second group of records described pertain to the overseas activities of the German Navy during the period 1854-1914. These materials document the navy's establishment of overseas stations and commands (particularly the *Kreuzergeschwader*, 'Cruiser Squadron'), its involvement in the establishment and maintenance of overseas colonies, and its role in gunboat diplomacy. A greater level of description accompanies these records in order to identify the various overseas stations over time and the specific warships involved in specific missions. The records particularly document the navy's involvement in the establishment and protection of colonies in East Africa and Tsingtao (China), naval participation in the suppression of the Boxer Rebellion and the Herero uprising, and the blockade of Venezuela. Again the contents of several files complement each other, e.g., the naval role in the establishment of German East Africa is documented in Acta XII.2.4.41, XII.2.4.43 and XII.3.1.114. Only one file (Acta XII.3.1.114, Band 14) includes information relating to World War I. A separate introduction accompanies this collection.

The third group of records described consists of the correspondence and reports of German naval attachés, 1901 – 1930. Most of these records were maintained by the Reichs-Marine-Amt (Zentralabteilung), as the attachés submitted their correspondence and reports to the Staatssekretär, the head of the Reichs-Marine-Amt. The records are arranged by country of assignment, thereunder divided into correspondence (Schriftwechsel) and reports (Berichte), and thereunder arranged chronologically. At the end of this collection are some files of correspondence received from foreign naval attachés, generally arranged by country, and some Kaiserliches Marinekabinett files that mostly pertain to personnel matters associated with the naval attachés and their staffs. Little description has been provided for these records, instead the precise chronological identification of each attaché's correspondence and reports on microfilm has been emphasized. Many of the attachés' materials extend into World War I; for some (e.g., the attachés in Norway, Denmark, the Netherlands, Greece, Bulgaria and Romania, Turkey, and Spain), their offices were not established until after war's outbreak, hence all of their

correspondence and reports comprise wartime materials. A separate introduction also accompanies this collection.

In addition to extensive official correspondence and reports, these collections include tables of organization and future fleet projections, copies of parliamentary proceedings relating to naval legislation, and copies of German and foreign newspaper clippings. Scattered among these collections are materials in English, Spanish, and French. A number of documents bear the signatures of Wilhelm I (in his various titles as Wilhelm Prinz von Preußen, Wilhelm König von Preußen, and Wilhelm Imperator Rex [I.R.], Deutscher Kaiser) and of his son, Kaiser Wilhelm II, as well as of Admiral Alfred von Tirpitz, State Secretary of the Reich Navy Office, and other prominent figures from Imperial Germany. Some duplication of materials can be found among the files.

The records also document changes in the German language from the 19<sup>th</sup> into the 20<sup>th</sup> century. The spellings of several words changed with simplification, e.g., from "Thätigkeit" to Tätigkeit, "Abtheilung" to Abteilung, and "Entwickelung" to Entwicklung. Other terms fell from usage, to be replaced by others: Classified German Navy records in the late 19<sup>th</sup> century, for example, might be marked "Secret," but by World War I the accepted terms had become "Geheim" and "ganz Geheim."

All original records described have been returned to Germany and are now in the custody of the Bundesarchiv – Abt. Militärarchiv (BA-MA) in Freiburg/Br. German archivists disregarded the centralized "Friedensakten" arrangement and attempted to restore the original provenance and maintain the appropriate organizational hierarchy. As a result, the organizational and central files of various naval authorities for the period prior to 1889 now constitute Bestand RM 1, Kaiserliche Admiralität; records of the Kaiserliches Marinekabinett constitute Bestand RM 2; those of the Reichs-Marine-Amt, Bestand RM 3; those of the Admiralstab der Marine, Bestand RM 5; and those for Marineattachés, Bestand RM 12. Finding aids (Findbücher) for each of these record groups is available at the BA-MA in Freiburg.

This guide pertains only to identifiable record items reproduced on Microfilm Publication T1022. Such selective identification reflects the unsystematic and incomplete acquisition of German naval records at the end of World War II. German naval records from the 1850-1914 period, in contrast to those for World War II, survived the latter conflict relatively intact, but were of secondary interest to the U.S. Navy's microfilming project in London, where priority lay with filming as many German Navy operational records from the two conflicts as possible. Therefore a number of pre-World War I era German Navy records brought from Germany to London by Allied authorities were not filmed by the U.S. Navy team operating there from July 1945 to August 1947. These include a significant number of prewar contingency plans and operational studies, among them plans for the eventuality of a war with the United States ("Acta III.1.-.16, Acta betr. Vorarbeiten zu den Operationsplänen gegen die Vereinigten Staaten von Nordamerika, Bände 1-4"), originally catalogued as record item F 5174b, now identified in BA-MA custody as RM 5/5960-5963.

No reference has been made to these and other discrete collections of records not filmed (e.g., from the records of the *Kaiserliches Marinekabinett*), but where specific volumes of otherwise-filmed series are known or believed to have been omitted from filming, references have been included to their presumed retention in the BA-MA.

The "PG" record item numbers represent a numerical registry system used by British authorities as records arrived for exploitation in Great Britain. Although German Navy records predating 1930 tended to be assigned sequential 'blocks' of "PG" registry numbers, no specific attempt was made to correlate existing German file designations with "PG" numbers. The U.S. Navy's microfilming project was defined by the availability of records, and made no attempt to systematically film "PG" record items in numerical sequence. No frame numbers were used in the filming, hence the "PG" record item identifications provide the only intellectual control to the contents of individual rolls. The roll numbers initially assigned by the U.S. Navy (e.g., T-1-A, T-1-B) were replaced by a consecutive numerical sequence after they were accessioned by the National Archives and collectively redesignated Microfilm Publication T1022. The first 1,659 numbered T1022 rolls reproduce records predating 1930. Listings of the roll numbers on which the records described for each of the three groups are reproduced can be found at the end of the descriptions for each group, and a combined listing of all rolls whose contents are described in this guide is also provided.

The British accession lists of "PG" record items, sometimes known as the "Sanders list" after its compiler, Lt. Cdr. Samuel R. Sanders of the Royal Navy, grouped pre-1930 German Navy records in general by organizational hierarchy and included original German file designations, titles, and date spans as well as "PG" record item numbers; these lists were subsequently annotated to indicate those record items filmed by the U.S. Navy (using the T-1-A, T-1-B, etc. designations noted above). Copies of these accession lists are reproduced on T1022 roll 1. The U.S. Navy later prepared descriptive lists of the filmed "PG" record items which include English-language summaries of their contents, copies of which for the first 1,659 microfilm rolls are reproduced on T1022 roll 2.

The information provided in these accession and roll lists served as the foundation for this guide, supplemented by a direct review of the records themselves. For a more detailed history of the German Navy and of the seizure and microfilming of the records, see the Introduction by Harry E. Rilley in *Guides to Microfilmed Records of the German Navy, 1850-1945: No. 1, U-Boats and T-boats, 1914-1918* (Washington, DC, 1984), pp. iii-xvi; and the essays by Howard M. Ehrmann, "The German Naval Archives (Tambach)," and Ernest M. Eller, "United States Navy Microfilm of the German Naval Archives," both in Robert Wolfe, ed., *Captured German and Related Records: A National Archives Conference* (Athens, OH, 1974).

#### GLOSSARY OF SELECTED TERMS AND ABBREVIATIONS

Acta/Akte: prefix designation for a subject correspondence file ('Acta' represents the older form)

Adhibendum: (latin) archaic term for 'attachment' as in an enclosure or appendix to another document

Admiralstab der Marine: Admiralty Staff or General Staff of the Navy, an executive operational staff, originally a component of the Kaiserliche Oberkommando der Marine which survived that body's dissolution in 1899

**BA-MA**: Bundesarchiv – Abt. Militärarchiv, the principal repository for German military and naval records, located in Freiburg/Br., Germany

Band: volume

Bestand: Bundesarchiv designation for record group

betr.: abbreviation for "betreffend," used in file titles as "regarding" or "concerning"

Bundesmarine: "Federal German Navy," term applied to the combined German Navy during the 1848/49 period, the Navy of the North German Confederation (1867 -71), and the present German Navy

Ganz Geheim (G.G.): German Navy security classification term for the World War I era, approximately equivalent to "Top Secret"

Geschwader: squadron (of warships)

Heft: volume or issue number

Immediatherichte/ Immediatevorträge: reports and oral presentations made directly to the Kaiser, from those naval authorities so authorized

Kaiserliche Admiralität: Imperial Admiralty, established in January 1872 as the central executive authority of the Imperial German Navy, dissolved March 1889

Kaiserliches Marinekabinett (or Marine-Kabinett): Imperial Naval Cabinet, a staff of advisors established by the Kaiser in April 1899 to facilitate his personal command of the Navy and naval affairs, but which in practice concentrated on naval officers' personnel matters and ceremonial functions Kgl.: abbreviation for "Königlich," Royal

Kgl. Preußische Admiralität: Royal Prussian Admiralty, the central executive authority of the Royal Prussian Navy from November 1853 to April 1861

Konter-Admiral: German Navy rank equivalent to Rear Admiral

Kreuzergeschwader: 'Cruiser Squadron,' term generally associated with the formation of German cruisers and supporting warships based at Tsingtao in China, 1897-1914

Kreuzerkrieg: cruiser or commerce warfare, a naval strategy based on the raiding of enemy merchant shipping

Marine-Expeditionskorps: term for German Navy marines employed in Southwest Africa to assist in the suppression of native uprisings, 1904-06

Marine-Rundschau: name of a professional naval journal in Germany (still in existence)

Novelle: supplement to a specific act of legislation, used in connection with supplementary Navy bills in the 1900-1912 period

Ostasiatisches Expeditionskorps: term for German Navy marines employed in China to assist in suppressing the Boxer Rebellion, 1900-01

Ostasiatisches Geschwader: term initially applied to a reinforced German naval presence on the East Asia Station (particularly in the late 1850s and 1876), later to the squadron of warships stationed at the naval base and attendant colony of Tsingtao in China; eventually superseded by Kreuzergeschwader

Reichsgesetzblatt: the official German Government gazette for the publication of laws

Reichskanzler: Reich Chancellor, the chief executive of the German Government

Reichskommissar: 'Reich Commissar,' term for an appointed civil administrator in a colony or occupied area

Reichs-Marine-Amt (R.M.A.): Reich Navy Office, established in April 1889 as the agency responsible for organization and administration of the Imperial German Navy, under the direct authority of *Staatssekretär* (State Secretary) Admiral (later Grand Admiral) Alfred von Tirpitz

Reichstag: the German Parliament

Schutztruppe(n): designation for German colonial forces, often under naval authority

S.M.S.: "Seiner Majestät Schiff," His Imperial (German) Majesty's Ship, prefix for warship designations

Vol.: Volume, used by German naval authorities in the mid-19<sup>th</sup> century before being replaced by "Band" and "Heft"

## ORGANIZATIONAL RECORDS OF THE PRE-WORLD WAR I ERA

I. KRIEGS-MINISTERIUM/ KAISERLICHE ADMIRALITÄT/ OBER-KOMMANDO DER MARINE/ MARINE-MINISTERIUM/ REICHS-MARINE-AMT (1822 – 1889)

Records of the Kaiserliche Admiralität, established on 1 January 1872, include those organizational materials inherited from previous executive authorities in the evolution of the Prussian/German Navy, from the Abt(h)eilung für Marine-Angelegenheiten within the Prussian Kriegsministerium through the Ober-Commando der Marine, the Kgl. Preussische Admiralität, and the Marine-Ministerium. The records, which document the essential organizational planning and funding for the Navy in the early period, were subsequently reorganized into a single numeric-subject arrangement as indicated; the originals today constitute part of Bestand RM 1 (Kaiserliche Admiralität) in the custody of the BA-MA, Freiburg/Br., Germany.

## II. KAISERLICHES MARINEKABINETT (1889-1918)

The Kaiserliches Marinekabinett (or Marine-Kabinett), established on 1 April 1889 by Kaiser Wilhelm II. to facilitate his personal command of the Navy and naval affairs, in practice developed into the most significant office in naval officers' personnel matters. The pre-World War I records described here document the Kaiser's personal involvement in naval matters, including key policy and organizational issues. Other records of the Marine-Kabinett for this period are described elsewhere in this finding aid; the originals are held at the BA-MA as part of Bestand RM 2.

Originally a component of the Ober-Kommando der Marine, the Admiralstab der Marine became in 1899 an independent agency directly subordinate to the Kaiser, responsible for operational planning and the collection and evaluation of intelligence on foreign powers, particularly regarding naval matters. IV. REICHS-MARINE-AMT/Nachrichtenbureau and Zentralabteilung (1897-1920)
The Reichs-Marine-Amt was established in 1889 as the chief authority for organizational, administrative, technical, and ordnance matters within the Imperial German Navy, and operated under the direct control of Admiral Tirpitz as State Secretary. Records of the Nachrichtenbureau relate to publications and press matters, those of the Zentralabteilung extensively document the background and preparatory work for the naval legislation that allowed the buildup of a modern German battle fleet, and the accompanying political and diplomatic consequences for Anglo-German relations. Additional records of Reichs-Marine-Amt offices are described elsewhere in this finding aid. The original records are held by the BA-MA as part of Bestand RM 3.

### NAVAL RECORDS RELATING TO OVERSEAS STATIONS, GUNBOAT DIPLOMACY, AND COLONIES, 1854-1913

Introduction. This finding aid describes records of the Imperial German Navy and its predecessors relating to the furtherance of overseas trade and interests, the establishment and maintenance of overseas colonies, and overseas military operations for the approximate period 1854 – 1913 reproduced on ca. 80 rolls of National Archives Microfilm Publication T1022, Records of the German Navy, 1850-1945, Received from the Naval History Division. The records document the overseas activities, successively, of the Prussian Navy (1854-67), the North German Federal Navy (Bundesmarine) (1867-71), and the Imperial German Navy (Kaiserliche Marine) (1871-1918).

The records are arranged in two groups. The first and larger collection constitutes records originated by several naval authorities and departments during the period 1854-1909, and which were subsequently combined into a single subject-numeric filing arrangement. The second collection represents records maintained by the *Kaiserliches Marinekabinett*, 1889-1913, which were later also integrated into the subject-numeric filing arrangement. Following the records' return to Germany, the *Bundesarchiv* restored an arrangement into several record groups by provenance, as indicated in the Introduction to this Guide.

Because of their age, the condition of the files is sometimes poor, with original cover pages either missing or being unreadable; often such pages carry the notation "reponirt' (replaced). Records predating 1900 are handwritten in the old German Schreibschrift (Süterlin), requiring a familiarity with that style to understand the contents. German terminology and spellings also differ from 20th century practice, such as the use of "Secret" for classified records instead of the later "Geheim," and the term "Acta" instead of "Akte." A familiarity with 19th-century names for geographic locations is also required, e.g. the 'Hermit Island' for New Guinea, 'Angra Pequena' for what would later be Lüderitz Bay in Southwest Africa (now Namibia). The records include correspondence of Prussian/German naval authorities and operational officers, Foreign Ministry and consular representatives, and foreign government authorities, as well as German and foreign press newspaper clippings. Scattered throughout are materials in English, Spanish, and French. Many documents bear the signature of Wilhelm I in his various titles, initially as Wilhelm Prinz von Preußen, later as Wilhelm König of Preußen and Wilhelm Imperator Rex (I.R.) - Deutscher Kaiser. Also included are letters signed by Otto von Bismarck and Gen. Albrecht Graf von Roon, Prussian War Minister, as well as General and Admiral Albrecht von Stosch, Vice-Admiral Carl Ferdinand Batsch, and Gen. Leo von Caprivi, key figures in the early history of the Navy. Often a handwritten index of the contents is provided at the beginning of each file.

Scattered throughout the records are cross-references to related reports and other documents filed elsewhere among German naval archives according to the same subject numeric filing scheme. This is particularly applicable to reports filed by individual German warships, often relating to military actions, generally filed under the original designation XII.3.1.1 - .113; although these were seized by the Allies and redesignated PG 65140 - 65518, they were not filmed by the U.S. Navy and are now only available in the *Bundesarchiv-Abt*. *Militärarchiv* (BA-MA).

This collection gives valuable insight into the creation of the German Navy and its role in establishing German overseas trade and the protection of German national interests abroad. The records illustrate the evolution of such efforts under the aegis of the Kingdom of Prussia, the North German Confederation, and the unified German Empire. In autumn 1867, the Bundesmarine established five overseas "stations" to which ships were regularly rotated for the maintenance of German interests: (1) East Asia, East Africa, and East India; (2) the eastern coast of North America and the West Indies; (3) the west coasts of North and South America; (4) the east coast of South America; and (6) the Mediterranean. Later these were revised to: (1) East Asia, (2) Australia, (3) East Africa, (4) West Africa, (5) America, and (6) the Mediterranean. The records particularly document the assignment and activities of specific vessels on these stations. By the 1880s the records especially illuminate the role of the Navy in establishing and supporting individual colonies and protectorates, including information on military operations against revolts and insurrections. In addition to the protection of overseas trade, business interests, and colonies, the records also extensively document Prussian/German interests in the Mediterranean, particularly the eastern Mediterranean and the regions nominally under Ottoman control. Germany's participation in international military demonstrations and actions (notably the Boxer Rebellion in China) is also documented, as are disputes with the United States and other powers in the pursuit of imperialism. Finally the records furnish insight and the German perspective on regional events and conditions, e.g. the 1870s insurrection in Cuba and Spain's efforts to control the colony; conditions in Japan and China as they are opened to Western commerce and influence; and observations on the German and ethnic German populations in Latin and North America.

Excluded, however, are records of German naval operations directly associated with the Wars of Unification. No naval records directly pertaining to the Danish War (1862-64), the Austro-Prussian War (1866), or the Franco-Prussian War (1870-71) have been identified among those microfilmed, these may have been segregated as discrete collections prior to filming.

#### RECORDS RELATING TO GERMAN NAVAL ATTACHÉS, 1901-1930

Records of German naval attachés (Marine-Attachés) prior to and during World War I were maintained by the Zentralabteilung (Central Department) of the Reichs-Marine-Amt.

Correspondence and reports prepared by the attachés were submitted to the State Secretary (Staatssekretär), the head of the Reichs-Marine-Amt. The Zentralabteilung organized the records from each attaché into correspondence (Schriftwechsel) and reports (Berichte), each of which was thereunder arranged chronologically (with some overlap). The correspondence, comprising letters and telegrams exchanged between the naval attaché and various German naval authorities, always constitutes the larger collection. This arrangement was maintained in the German naval archives through the end of World War II, when the records fell into Allied hands. The original records now constitute part of Bestand RM 12, Marineattachés, at the Bundesarchiv-Abt. Militärarchiv (BA-MA), Freiburg/Br.

The attachés' correspondence and reports primarily concerned naval affairs and developments in the host countries, including information on naval organization and personnel strength, naval officer and enlisted mens' qualifications and training, relevant parliamentary legislation and budgetary data, warship design and construction, naval bases, schools, and shipyards, fleet maneuvers, and relevant technological developments in ordnance, propulsion systems, and communications equipment. In addition the records describe significant political and diplomatic matters, popular opinion on key issues, merchant marine and foreign trade information, and routine administrative matters within the attaché's office. Records for naval attachés in countries allied to Germany or neutral during World War I continued throughout the conflict and contain such significant documentation of the war as perceived reactions to unrestricted submarine warfare, relations of neutrals with the Allied and Central powers, general military and political intelligence on the Allies, and specific incidents pertaining to sinkings or internment of naval personnel. The records thus constitute an invaluable source on Germany's relations with other powers prior to World War I, as well as provide key documentation on the conflict itself.

Each volume (Band) is arranged chronologically, but enclosures to correspondence often include documentation that predates the indicated date span for the volume. Although many records were typed, some are handwritten, and typed documents often bear handwritten annotations. Often appended to correspondence and reports are copies of press clippings and publications in the original language of the host country. The final volume of correspondence or reports from attachés in countries that declared war on Germany typically cover both the last days before the termination of diplomatic relations and the restoration of relations at the conclusion of hostilities. A handwritten table of contents is located at the beginning of each volume that keys correspondence subjects to specific dates.

Also described here are three supplementary collections. The first, also maintained by the Reichs-Marine-Amt's Zentralabteilung, comprises correspondence exchanged with foreign naval

attachés during the approximate period 1892-1930, which often include extensive documentation for the 1920s. The second supplementary collection consists of records maintained by the *Reichs-Marine-Amt's Nachrichtenbüro* (Information/Publicity Bureau), relating mostly to press and publicity issues and extending throughout the entire World War I period; the originals comprise part of *Bestand RM 3*, *Reichs-Marine-Amt*, at the BA-MA. The final collection comprises records of the *Kaiserliches Marinekabinett (Bestand RM 2* at the BA-MA), mostly pertaining to personnel matters associated with the naval attachés and their staffs (e.g., appointments, promotions, transfers, granting of furloughs).
